

#### **Prior Authorization**



B25-124 was introduced in February 2023 by Councilmember Brooke Pinto. Guided by AMA best principles and led by MSDC, the bill received a hearing May 2023 where physicians spoke out in favor of the legislation. It passed the Council that fall and became law in February 2024.

In 2024, MSDC led the charge to ensure the law applied to **all** insurers. The original bill only applied to private insurers but the FY25 District budget included funding for the Medicaid and Alliance program to fund the law's requirements. As of October, all District residents – regardless of insurance – are protected from insurance abuse by a law that is among the most pro-medicine in the country.

In 2025 and beyond, MSDC will continue to push for updates to reflect changes in medicine. This monumental law would not be possible without organized medicine working together to share why prior authorization is abused by insurers and how that impacts patients.

### **Scope of Practice**



In the fall of 2023, DC Health unveiled long-awaited reforms to the statute governing health licensing. As part of the bill, DC Health pushed for major scope of practice expansions for most professions. Egregious examples included allowing podiatrists to operate on wrists, chiropractors to order medical tests, and pharmacists to offer medical advice on STIs and HIV.

Thanks to assistance from the AMA Scope of Practice Partnership, the DC "house of medicine" rallied together to create a coalition opposing the scope of practice expansion provisions in B25-545. While not every provision was removed, the quick work by physicians ensured many offensive provisions were removed. People interested can learn more at msdc.org/scope.

Already DC Health is drafting regulations on new scope of practice expansions based on the law, so MSDC remains vigilant in protecting patient care.

### Other Advocacy Wins

#### Legislation

- MSDC members pushed for introduction of the now-law copay accumulators act.
- The Council passed a resolution recognizing Lung Cancer Awareness month and specifically praising MSDC's work in lung health and smoking-cessation efforts.
- MSDC successfully defeated legislation to require physicians to take CME on violence as part of the license renewal.

#### Bowser Admin

- MSDC was invited to participate in the DC Healthcare Workforce Task Force and Opioid Abatement Task Force.
- The MSDC Board held two meetings at DC Health to discuss top organizational priorities.
- MSDC broke the news about changes to the medical license renewal timeline.
- In 2023, MSDC successfully advocated for regional medical license reciprocity
